Policy and Conditions

Being up front and honest about what you can expect from Odd Ball Web is tantamount to a successful business relationship.

Before Any Service begins, a requisite deposit of \$150.00 (one hundred fifty dollars) is due and payable to Odd Ball Web.

All Services are done in an orderly and direct relationship to the amount of up front information that Odd Ball Web is provided. If you have an idea or a concept, artwork, logo's, graphics, textual content, pages you know you may want and or require, and or competing web sites that you like the "look and feel" of, then please provide as much information that you can in the initial stages of development. We do offer unlimited site wide updates at no cost to you, however that does not include major layout or graphical changes to the site once agreed upon. For those of you who are not sure what you want or would like, please fill out this brief online form (or download here) and provide as much detail that you believe will assist in developing what you envision as your web site. When provided with all the information that is required for your website's development, your site can be up in as little as 3-5 days from concept to completion. This depends on you. If you have a need to have your site up as fast as possible, please provide as much detailed information as possible to avoid any lengthy delays.

Artwork submission is your responsibility. If you provide to me copyright materials that is not your property you are responsible for permissions and legal fees that may evolve from using such material.

Legally obtained artwork or original artwork you provide needs to be at least 75 pixels per inch (300px preferred) and should be at least 300px x 300px so that when manipulating the images there is no loss in clarity.

Any material deemed to be plagiarized, whether written, reproduced or questionable may not be used per the review of Odd Ball Web.

Once an order has been placed and a deposit received the balance on the site is due and payable in full within 90 days of the start date. Start date is the date in which the deposit has cleared or has been approved by Odd Ball Web. Unless other arrangements have been made due to unforeseen circumstances, this practice is not negotiable. This is meant to ensure that your commitment to the sites creation is done in a reasonable and timely manner. Typical site creation can take as little as 3 days from order as long as the materials for your site are in order as noted above.

There is no obligation to renew your yearly subscription and domain hosting is good for one year from date your site is registered or hosted with Odd Ball Web. Since database hosting is done on the Odd Ball Web servers, the proprietary obligation is the database structure and it's contents in full by back up of database. Physical hosting of database information terminates upon breach of contract, or election not to renew.

All material created for your website, and paid for in full become the property of the business in which they were created. Including all sketches, rough drafts, edits and files. **AS LONG AS THEY ARE PAID FOR IN FULL** based on the Fee Schedule below.
